FIRST AID MEASURES

First aid measures

General

: In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

Inhalation

Remove to fresh air. Keep person warm and at rest. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Give nothing by mouth. If unconscious, place in recovery position and seek medical advice.

Skin contact

: Remove contaminated clothing and shoes. Wash skin thoroughly with soap and water or use recognized skin cleanser. Do not use solvents or thinners.

Eye contact

Check for and remove any contact lenses. Immediately flush eyes with running water for at least 15 minutes, keeping eyelids open.

Ingestion

: If swallowed, seek medical advice immediately and show this container or label. Keep person warm and at rest. Do not induce vomiting.

FIRE-FIGHTING MEASURES

Extinguishing media

6. ACCIDENTAL RELEASE MEASURES

Personal precautions Spill

- : Avoid breathing vapor or mist. Refer to protective measures listed in sections 7 and 8.
- : Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13). Do not allow to enter drains or watercourses. Preferably clean with a detergent. Avoid using solvents. If the product contaminates lakes, rivers, or sewers, inform the appropriate authorities in accordance with local regulations.

7. HANDLING AND STORAGE

Handling

: Due to the organic solvents content of the preparation:

Vapors are heavier than air and may spread along floors. Vapors may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapors in air and avoid vapor concentrations higher than the occupational exposure limits.

In addition, the product should only be used in areas from which all naked lights and other sources of ignition have been excluded. Electrical equipment should be protected to the appropriate standard.

Keep container tightly closed. Keep away from heat, sparks and flame. No sparking tools should be used.

Avoid contact with skin and eyes. Avoid the inhalation of dust, particulates, spray or mist arising from the application of this preparation.

Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking.

Put on appropriate personal protective equipment (see section 8).

Never use pressure to empty. Container is not a pressure vessel. Always keep in containers made from the same material as the original one.

Storage

 Store in accordance with local regulations. Observe label precautions. Store in a cool, wellventilated area away from incompatible materials and ignition sources.

Exposure controls/personal protection

Occupational exposure controls

: Use only with adequate ventilation. Use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure to airborne contaminants below any recommended or statutory limits. EXPOSURE CONTROLS/PERSONAL PROTECTION

Respiratory protection

Use a properly fitted, air-purifying or air-fed respirator complying with an approved standard if a risk assessment indicates this is necessary. Recommended: In situations where misting or flying may occur, use appropriate certified respirators. (as filter A)

Hand protection

11. TOXICOLOGICAL INFORMATION

There is no data available on the preparation itself. The preparation is not classified as dangerous according to Directive 1999/45/EC and its amendments.

Exposure to component solvent vapor concentrations in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system. Symptoms and signs include headache, dizziness, fatigue, muscular weakness, drowsiness and, in extreme cases, loss of consciousness

Solvents may cause some of the above effects by absorption through the skin.
